## Illinois

### CSBG NETWORK PARTICIPANTS

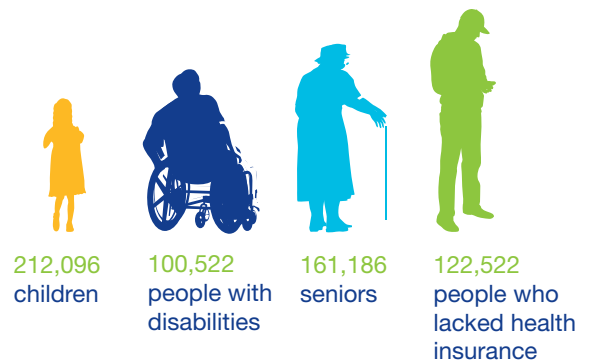
Illinois administers CSBG to  
37 agencies in  
100% of IL counties

75% of IL families served were in  
poverty, below 100% of the Federal  
Poverty Guidelines

34% of IL families served were in  
severe poverty, below 50% of the  
Federal Poverty Guidelines

The CSBG Network provided services to  
**1,080,329 low-income individuals in  
519,156 families in Illinois.**

Vulnerable populations served included:



Nationally, 1,040 agencies receiving CSBG  
funding provided services to 15.7 million low-  
income individuals in 6.7 million families.

Of the 6.7 million families nationwide, 70%  
of those families were living in poverty, below  
100% of the Federal Poverty Guidelines.

### CSBG NETWORK RESOURCES

For every \$1 of CSBG, the IL Network leveraged  
**\$7.79** from state, local, and private sources,  
including the value of volunteer hours\*



**\$26,985,327** CSBG funds were  
allocated in support of the IL  
CSBG Network

The IL Network's non-CSBG  
funding totaled **\$779,189,100**

Including all federal sources and  
volunteer hours, the IL CSBG  
Network leveraged  
**29.44** per \$1 of CSBG

## CSBG PERFORMANCE OUTCOMES FOR ILLINOIS

Below is a subset of the IL Network's 2,614,897 outcomes, including indicators of movement toward self-sufficiency and community revitalization.

### Outcomes Include:

**906,422 Employment or Work Supports**

Low-income participants in CSBG Network employment initiatives obtained supports which reduced or eliminated barriers to initial or continuous employment, acquired a job, obtained an increase in employment income, or achieved "living wage" employment and benefits.

**18,387 Economic Asset Enhancement and Utilization**

Low-income households achieved an increase in financial assets or financial skills as a result of CSBG Network assistance.

**189,343 Child and Family Development**

Infants, children, youth, parents, and other adults participated in developmental or enrichment programs facilitated by the CSBG Network and achieved program goals.

**344,190 Independent Living for Low-Income Vulnerable Populations**

Low-income vulnerable individuals received services from the CSBG Network and secured or maintained an independent living situation as a result.

**473,962 Family Stability**

Low-income participants obtained supports which reduced or eliminated barriers to family stability through assistance from the CSBG Network.

**541,956 Emergency Assistance**

Low-income individuals and families received emergency assistance from the CSBG Network.

**107,621 Community Opportunities and Resources**

Community opportunities or resources were improved or expanded for low-income people as a result of CSBG Network projects or initiatives, or advocacy with other public and private agencies.

**33,016 Community Empowerment**

Community members and low-income people mobilized to engage in activities that support and promote their own well-being and that of their community as a direct result of CSBG Network initiatives through maximum feasible participation.
