California

CSBG NETWORK PARTICIPANTS

The California State Office administered CSBG funds to 60 Community Action Agencies in 100% of CA counties.

In California, Community Action Agencies provided services to 1,780,958 low-income individuals.

73% of families served by the CSBG Network lived below 100% of the Federal Poverty Guidelines.

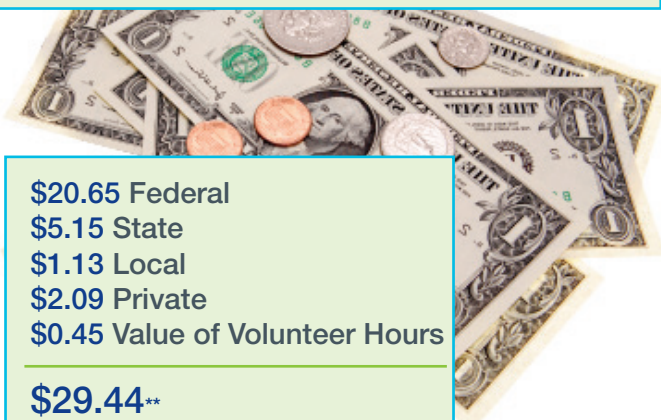
36% of families served in CA were in severe poverty, below 50% of the Federal Poverty Guidelines.

Nationally, 1,026 Community Action Agencies receiving CSBG funding provided services to 15.6 million individuals with low-incomes.

Nationally, of the 6.6 million families served by the CSBG Network, 82.6% were living below 125% of the Federal Poverty Guidelines.

CSBG NETWORK RESOURCES

For every \$1 of CSBG, the CA Network leveraged \$29.44 from federal, state, local, and private sources, including the value of volunteer hours.*



\$59,802,390 in CSBG funds were allocated in support of local entities in California.

The CA Network's non-CSBG funding totaled \$1,669,671,045.07.

CSBG PERFORMANCE OUTCOMES FOR CALIFORNIA

Services and strategies provided by the CA Network resulted in **1,899,559 outcomes for participants and communities with low incomes.**

Outcomes Include:

257,428

Employment

Participants with low incomes in the CSBG Network employment initiatives obtained supports which reduced or eliminated barriers to initial or continuous employment, acquired a job, increased their income, or achieved “living wage” employment and benefits.

89,605

Economic Asset Enhancement and Utilization

Households with low incomes increased their financial assets or financial skills.

296,951

Child and Family Development

Infants, children, youth, parents, and other adults participated in developmental or enrichment programs facilitated by the CSBG Network and achieved program goals.

209,854

Independent Living for Vulnerable Populations with Low Incomes

Vulnerable individuals with low incomes received services from the CSBG Network and secured or maintained an independent living situation as a result.

119,246

Family Stability

Participants with low incomes obtained supports which reduced or eliminated barriers to family stability through assistance from the CSBG Network.

711,140

Emergency Assistance

Individuals and families with low incomes received emergency assistance from the CSBG Network.

Community Opportunities and Resources

Community opportunities or resources were improved or expanded for people with low incomes as a result of CSBG Network projects or initiatives, or partnerships with other public and private agencies.

Community Empowerment

Community members and people with low incomes mobilized to engage in activities that support and promote their own well-being and that of their community as a result of CSBG Network initiatives through maximum feasible participation.
