

### **Background Information on the Home:**

- Mr. and Mrs. Fred and Barbara Todd have lived in the home at 193 Fairlawn Avenue in Mansfield for 48 years.
- The home was built in 1929 and is 1,416 square feet in size.
- The home has natural gas heat, with an annual natural gas consumption of 1,300 ccf and electric consumption in excess of 7,000 kilowatt hours.
- The existing heating system and hot water tank needed a clean and tune and a flue liner.
- The existing roof was severely deteriorated and in need of replacement.
- The home had little insulation and high air leakage.

GLS's Home Weatherization Assistance Program (HWAP) provided the following:

- electric baseload measures
- carbon monoxide detectors on the 1st and 2nd floors
- water heater insulation and DHW pipe insulation
- blown cellulose insulation in the attic
- blown cellulose insulation in the sidewall cavities
- air sealing where needed

#### GLS's Columbia Gas WarmChoice Program provided the following:

- Clean and tune the furnace
- · Clean and tune the hot water tank
- Install a flue liner

#### The First Energy Community Connections Program provided the following:

GLS weatherization services include an energy inspection of each client's home. The inspection focuses on the heating system, insulation of the attic, floors and wall areas, reducing the air leakage into the home from the outside, as well as health and safety concerns. The weatherization process reduces a home's energy bills an average of twenty-five to thirty percent, or an estimated savings of \$ 600.00 per year for this home based on previous usage. These services are provided at no cost to the occupants.

- improved health and safety conditions
- increased comfort for the occupants
- extended lifespan for the housing unit
