**Job Duties:**

Manages implementation of Home Weatherization Assistance Program (i.e., HWAP), Electric Partnership Program (EPP) and HWAP Enhancement within Community Service Division's (i.e., CSD) Office of Community Assistance (i.e., OCA): provides work direction to staff in areas of administration, coordination & implementation of energy programs; supervises sub-grant process from plan development through evaluation of grantee performance for local program providers statewide.

Trains & supervises (e.g., distributes work assignments, monitors & evaluates performance, enforces policies, approves leave, gives direction) technical monitors who monitor compliance for & evaluate weatherization programs: ensures that staff is current with available knowledge about energy efficiency technologies; completes annual performance reviews for assigned staff; executes & implements U.S. Department of Energy (i.e., DOE) and applicable State of Ohio policies & procedures to ensure grantee compliance.

Advises OCA Assistant Deputy Chief, Deputy Chief, CSD Chief & other program managers on matters relating to energy efficiency programs: provides program information to legislature, local officials & general public; attends & presents information at meetings, conferences, workshops & seminars, as necessary; coordinates with OCA fiscal section on matters pertaining to sub-grants; travels as necessary to provide sub-grantees with technical assistance.

Directs development of annual HWAP State Plan: directs development of competitive request for proposals and oversees evaluation of proposals submitted; conducts annual HWAP public hearing & ensures that all required program reporting requirements are met.

Oversees implementation of OCA plan for Ohio Weatherization Training Center: coordinates & provides guidance on curricula & schedules to facilitate training of local agency work crews & Inspectors.

Demonstrates commitment to sound metrics, accountability & transparency while ensuring quality customer service.

1. Substantial experience in Home Weatherization Assistance Program administration or implementation Required.
2. Previous supervisory experience required.
3. Associate or bachelor's degree preferred.
4. Building technology (e.g., heating, cooling, ventilation) experience preferred.
5. Completion of Inspector Series courses or, completion of Building Performance Institute (BPI) Certification Test for inspectors or, Home Energy Rater Certificate preferred.

8. Must possess valid driver's license & be able to travel to various sites around Ohio & occasionally outside of Ohio.
