CSBG NETWORK PARTICIPANTS

The Minnesota State Office administered CSBG funds to **33 Community Action Agencies**.

In Minnesota, Community Action Agencies provided services to **416,340 low income individuals**.

59% of families served in MN by the CSBG Network lived below **100%** of the Federal Poverty Guidelines.

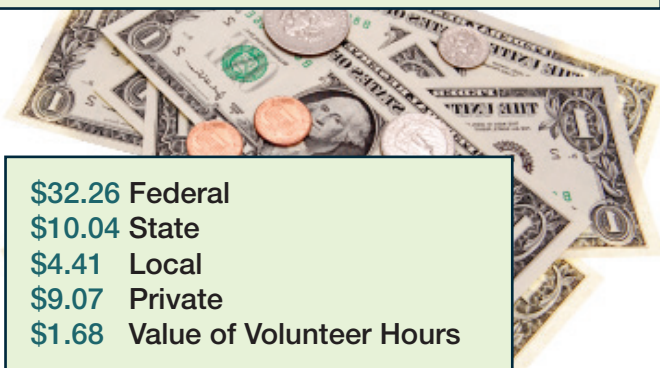
35% of families served in MN were in severe poverty, below **50%** of the Federal Poverty Guidelines.

Nationally, over **1,000 Community Action Agencies** receiving CSBG funding provided services to **15.3 million individuals with low incomes**.

Nationally, of the **6.3 million families** served by the CSBG Network who reported income, **82.8%** were living at or below **125%** of the Federal Poverty Guidelines.

CSBG NETWORK RESOURCES

For every **\$1** of CSBG, the MN Network leveraged **\$57.46** from federal, state, local, and private sources, including the value of volunteer hours.*

CSBG PERFORMANCE OUTCOMES FOR MINNESOTA

Services and strategies provided by the MN Network resulted in **1,157,954** outcomes for participants and communities with low incomes.

Outcomes Include:

254,717	Employment Participants with low incomes in the CSBG Network employment initiatives obtained supports which reduced or eliminated barriers to initial or continuous employment, acquired a job, increased their income, or achieved “living wage” employment and benefits.
17,962	Economic Asset Enhancement and Utilization Households with low incomes increased their financial assets or financial skills.
66,078	Child and Family Development Infants, children, youth, parents, and other adults participated in developmental or enrichment programs facilitated by the CSBG Network and achieved program goals.
157,166	Independent Living for Vulnerable Populations with Low Incomes Vulnerable individuals with low incomes received services from the CSBG Network and secured or maintained an independent living situation as a result.
192,895	Family Stability Participants with low incomes obtained supports which reduced or eliminated barriers to family stability through assistance from the CSBG Network.
134,736	Emergency Assistance Individuals and families with low incomes received emergency assistance from the CSBG Network.
308,312	Community Opportunities and Resources Community opportunities or resources were improved or expanded for people with low incomes as a result of CSBG Network projects or initiatives, or partnerships with other public and private agencies.
26,088	Community Empowerment Community members and people with low incomes mobilized to engage in activities that support and promote their own well-being and that of their community as a result of CSBG Network initiatives through maximum feasible participation.
