WHO WE SERVE...



For FFY2018:

There were 58 CAAs, serving 752,837 people with low incomes who were living in 401,493 families.

CAAs served 55,724 people who lacked healthcare, 63,973 people who reported having a disability, 66,736 senior citizens, 267,510 children living in poverty, and 4,827 veterans.

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

Goal 1 - Individuals and families with low incomes are stable and achieve economic security.

Goal 2 - Communities where people with low incomes live are healthy and offer economic opportunity.

Goal 3 - People with low incomes are engaged and active in building opportunities in communities.

California Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 2,741 non-profits
- 2,547 for-profits
- 1,034 faith based organizations
- 596 school districts



Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and

improve performance management. In FY18 there were 25 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.






There were 2,374,739 hours of volunteer time donated to CAAs in California.

Community Action Agencies leverage several other federal, state, local and other private funds.

For every \$1 of CSBG, California's CAAs leveraged \$27.64 from federal, state, local and private sources, including the value of volunteer hours.



- \$59,219,272 in CSBG funds were allocated in support of CAAs in California in FY18.
- Including, all leveraged funds California had \$1,678,876,990 available to the CAA network to improve the lives of people with low incomes in FY18.



17 CAAs in California also operate the Low Income Home Energy Assistance Program (LIHEAP).



24 CAAs in California also operate the Weatherization Assistance Program (WAP).



13 CAAs in California also operate a Head Start Program.

From the California FFY 2018 Community Services Block Grant

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social/behavioral development, and civic engagement and community involvement.

EMPLOYMENT

9,901,987 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

EDUCATION

6,295,908 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.



CIVIC ENGAGEMENT

1,765,608 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.

HOUSING

5,357,152 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

HEALTH

11,689,923 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.
