## WHO WE SERVE...



### For FFY2018:

There were 23 CAAs, serving 307,668 people with low incomes who were living in 152,273 families.

CAAs served 33,138 people who lacked healthcare, 67,181 people who reported having a disability, 23,535 senior citizens, 101,699 children living in poverty, and 156 veterans.

## WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

**Goal 1** - Individuals and families with low incomes are stable and achieve economic security.

**Goal 2** - Communities where people with low incomes live are healthy and offer economic opportunity.

**Goal 3** - People with low incomes are engaged and active in building opportunities in communities.

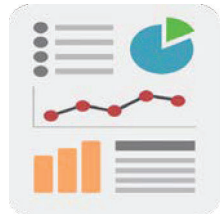
## What kinds of RESOURCES do CAAs have?

Kentucky Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 1,152 non-profits
- 1,363 for-profits
- 777 faith based organizations
- 384 school districts



Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and improve performance management. In FY18 there were 17 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.

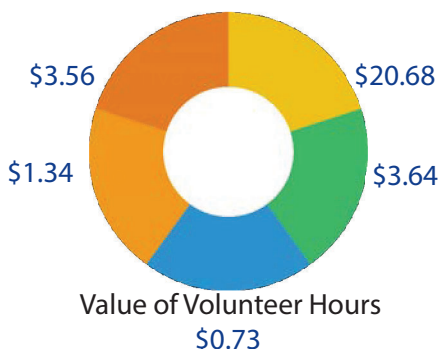


There were 1,239,896 hours of volunteer time donated to CAAs in Kentucky.

Community Action Agencies leverage several other federal, state, local and other private funds.

For every \$1 of CSBG, Kentucky's CAAs leveraged \$29.95 from federal, state, local and private sources, including the value of volunteer hours.

- \$12,289,354 in CSBG funds were allocated in support of CAAs in Kentucky in FY18.
- Including, all leveraged funds Kentucky had \$371,347,034 available to the CAA network to improve the lives of people with low incomes in FY18.



21 CAAs in Kentucky also operate the Low Income Home Energy Assistance Program (LIHEAP).



22 CAAs in Kentucky also operate the Weatherization Assistance Program (WAP).



17 CAAs in Kentucky also operate a Head Start Program.

From the Kentucky FFY 2018 Community Services Block Grant

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social/behavioral development, and civic engagement and community involvement.

## EMPLOYMENT

1,378,856 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

## EDUCATION

1,436,262 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

## HOUSING

1,825,435 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

## INCOME

675,306 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.

## CIVIC ENGAGEMENT

485,618 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.

## HEALTH

1,375,317 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.
