WHO WE SERVE...



For FFY2018:

There were 17 CAAs, serving 257,760 people with low incomes who were living in 108,177 families.

CAAs served 33,415 people who lacked healthcare, 37,513 people who reported having a disability, 18,859 senior citizens, 72,423 children living in poverty, and 2,675 veterans.

WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

Goal 1 - Individuals and families with low incomes are stable and achieve economic security.

Goal 2 - Communities where people with low incomes live are healthy and offer economic opportunity.

Goal 3 - People with low incomes are engaged and active in building opportunities in communities.

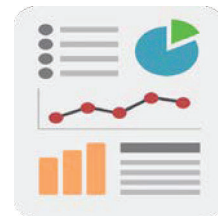
do CAAs have?

Maryland Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 529 non-profits
- 863 for-profits
- 500 faith based organizations
- 30 school districts



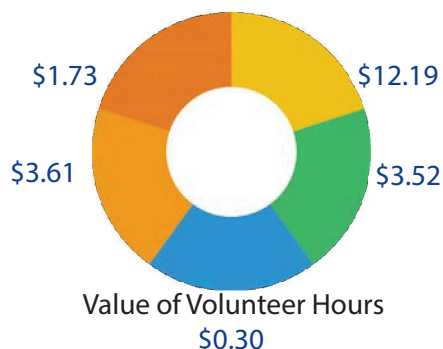
Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and improve performance management. In FY18 there were 19 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.



There were 264,721 hours of volunteer time donated to CAAs in Maryland.

Community Action Agencies leverage several other federal, state, local and other private funds.

For every \$1 of CSBG, Maryland's CAAs leveraged \$21.35 from federal, state, local and private sources, including the value of volunteer hours.



- \$6,468,131 in CSBG funds were allocated in support of CAAs in Maryland in FY18.
- Including, all leveraged funds Maryland had \$142,629,269 available to the CAA network to improve the lives of people with low incomes in FY18.

From the Maryland FFY 2018 Community Services Block Grant

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social/behavioral development, and civic engagement and community involvement.

EMPLOYMENT

582,149 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

EDUCATION

330,063 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

HOUSING

1,130,659 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

INCOME

539,385 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.

CIVIC ENGAGEMENT

254,496 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.

HEALTH

1,074,893 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.
