WHO WE SERVE...



For FFY2018:

There were 25 CAAs, serving 238,102 people with low incomes who were living in 140,474 families.

CAAs served 52,929 people who lacked healthcare, 31,193 people who reported having a disability, 23,343 senior citizens, 63,270 children living in poverty, and 3,029 veterans.

WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

Goal 1 - Individuals and families with low incomes are stable and achieve economic security.

Goal 2 - Communities where people with low incomes live are healthy and offer economic opportunity.

Goal 3 - People with low incomes are engaged and active in building opportunities in communities.

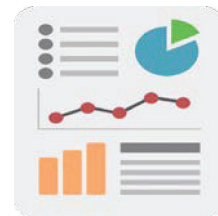
What kinds of RESOURCES do CAAs have?

New Jersey Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 971 non-profits
- 727 for-profits
- 306 faith based organizations
- 245 school districts



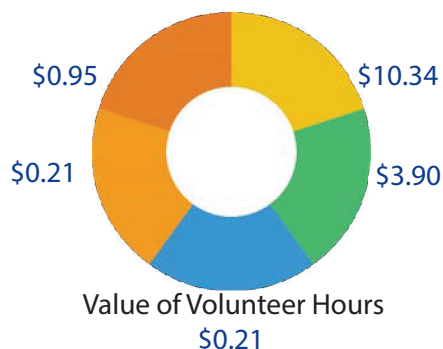
Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and improve performance management. In FY18 there were 8 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.



There were 471,643 hours of volunteer time donated to CAAs in New Jersey.

Community Action Agencies leverage several other federal, state, local and other private funds.

For every \$1 of CSBG, New Jersey's CAAs leveraged \$15.61 from federal, state, local and private sources, including the value of volunteer hours.

- \$16,597,806 in CSBG funds were allocated in support of CAAs in New Jersey in FY18.
- Including, all leveraged funds New Jersey had \$272,329,598 available to the CAA network to improve the lives of people with low incomes in FY18.

From the New Jersey FFY 2018 Community Services Block Grant

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social/behavioral development, and civic engagement and community involvement.

EMPLOYMENT

775,454 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

EDUCATION

1,901,363 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

HOUSING

3,083,234 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

INCOME

907,448 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.

CIVIC ENGAGEMENT

396,912 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.

HEALTH

2,345,251 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.
