## WHO WE SERVE...



### For FFY2018:

There were 34 CAAs, serving 63,297 people with low incomes who were living in 34,311 families.

CAAs served 26,131 people who lacked healthcare, 5,396 people who reported having a disability, 3,545 senior citizens, 27,079 children living in poverty, and 1,333 veterans.

## WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

**Goal 1** - Individuals and families with low incomes are stable and achieve economic security.

**Goal 2** - Communities where people with low incomes live are healthy and offer economic opportunity.

**Goal 3** - People with low incomes are engaged and active in building opportunities in communities.

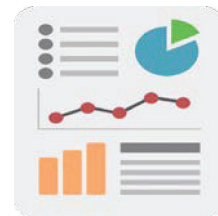
## What kinds of RESOURCES do CAAs have?

North Carolina Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 1,129 non-profits
- 1,140 for-profits
- 984 faith based organizations
- 150 school districts



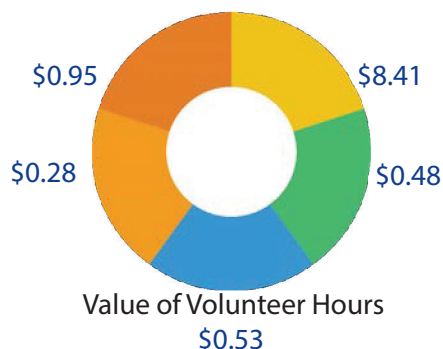
Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and improve performance management. In FY18 there were 40 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.



There were 1,737,590 hours of volunteer time donated to CAAs in North Carolina.

Community Action Agencies leverage several other federal, state, local and other private funds.

For every \$1 of CSBG, North Carolina's CAAs leveraged \$10.66 from federal, state, local and private sources, including the value of volunteer hours.



- \$23,637,938 in CSBG funds were allocated in support of CAAs in North Carolina in FY18.
- Including, all leveraged funds North Carolina had \$263,084,148 available to the CAA network to improve the lives of people with low incomes in FY18.



15 CAAs in North Carolina also operate the Low Income Home Energy Assistance Program (LIHEAP).



3 CAAs in North Carolina also operate the Weatherization Assistance Program (WAP).



22 CAAs in North Carolina also operate a Head Start Program.

From the North Carolina FFY 2018 Community Services Block Grant

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social/behavioral development, and civic engagement and community involvement.

## EMPLOYMENT

4,616,308 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

## EDUCATION

1,550,358 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

## HOUSING

925,950 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

## INCOME

387,870 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.

## CIVIC ENGAGEMENT

491,664 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.

## HEALTH

333,528 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.
