WHO WE SERVE...



For FFY2018:

There were 4 CAAs, serving 31,557 people with low incomes who were living in 14,941 families.

CAAs served 3,950 people who lacked healthcare, 10,578 people who reported having a disability, 3,063 senior citizens, 7,621 children living in poverty, and 121 veterans.

WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

Goal 1 - Individuals and families with low incomes are stable and achieve economic security.

Goal 2 - Communities where people with low incomes live are healthy and offer economic opportunity.

Goal 3 - People with low incomes are engaged and active in building opportunities in communities.

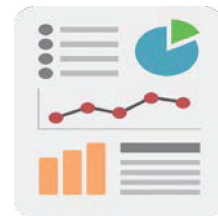
What kinds of RESOURCES do CAAs have?

Puerto Rico Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 110 non-profits
- 38 for-profits
- 45 faith based organizations
- 34 school districts



Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and improve performance management. In FY18 there were 20 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.

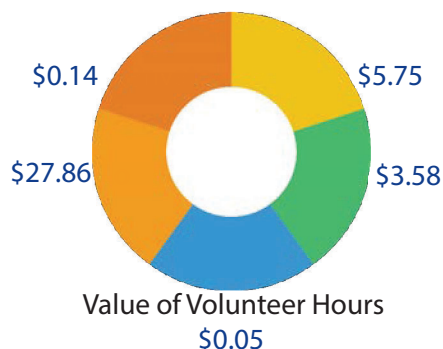


There were 182,186 hours of volunteer time donated to CAAs in Puerto Rico.

Community Action Agencies leverage several other federal, state, local and other private funds.

For every \$1 of CSBG, Puerto Rico's CAAs leveraged \$37.37 from federal, state, local and private sources, including the value of volunteer hours.

- \$26,721,113 in CSBG funds were allocated in support of CAAs in Puerto Rico in FY18.
- Including, all leveraged funds Puerto Rico had \$1,024,004,244 available to the CAA network to improve the lives of people with low incomes in FY18.



1 CAA in Puerto Rico also operates a Head Start Program.

From the Puerto Rico FFY 2018 Community Services Block Grant

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social/behavioral development, and civic engagement and community involvement.

EMPLOYMENT

6,759,880 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

EDUCATION

988,866 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

HOUSING

The housing domain includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

INCOME

147,815 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.

CIVIC ENGAGEMENT

341,278 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.

HEALTH

3,174,805 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.
