WHO WE SERVE...



For FFY2018:

There were 36 CAAs, serving 686,177 people with low incomes who were living in 333,533 families.

CAAs served 17,964 people who lacked healthcare, 123,043 people who reported having a disability, 98,904 senior citizens, 237,794 children living in poverty, and 1,551 veterans.

WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

From the Illinois FFY 2018 Community Services Block Grant

Goal 1 - Individuals and families with low incomes are stable and achieve economic security.

Goal 2 - Communities where people with low incomes live are healthy and offer economic opportunity.

Goal 3 - People with low incomes are engaged and active in building opportunities in communities.

Illinois Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 2,042 non-profits
- 1,202 for-profits
- 890 faith based organizations
- 584 school districts



There were 1,340,439 hours of volunteer time donated to CAAs in Illinois.

What kinds of RESOURCES

Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and

improve performance management. In FY18 there were 29 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.



Community Action Agencies leverage several other federal, state, local and other private funds.

For every \$1 of CSBG, Illinois's CAAs leveraged \$23.55 from federal, state, local and private sources, including the value of volunteer hours.



- \$36,300,352 in CSBG funds were allocated in support of CAAs in Illinois in FY18.
- Including all leveraged funds, Illinois had \$881,391,497 available to the CAA network to improve the lives of people with low incomes in FY18.



32 CAAs in Illinois also operate the Low Income Home Energy Assistance Program (LIHEAP).



31 CAAs in Illinois also operate the Weatherization Assistance Program (WAP).



19 CAAs in Illinois also operate a Head Start Program.

From the Illinois FFY 2018 Community Services Block Grant

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social/behavioral development, and civic engagement and community involvement.

EMPLOYMENT

25,585 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

EDUCATION

113,340 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

INCOME

42,981 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.



CIVIC ENGAGEMENT

55,711 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.

HOUSING

182,003 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

HEALTH

106,208 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.
