WHO WE SERVE...



For FFY2018:

There were 14 CAAs, serving 131,331 people with low incomes who were living in 54,755 families.

CAAs served 8,912 people who lacked healthcare, 17,387 people who reported having a disability, 11,150 senior citizens, 49,176 children living in poverty, and 552 veterans.



WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

- Goal 1** - Individuals and families with low incomes are stable and achieve economic security.
- Goal 2** - Communities where people with low incomes live are healthy and offer economic opportunity.
- Goal 3** - People with low incomes are engaged and active in building opportunities in communities.

What kinds of RESOURCES do CAAs have?

South Carolina Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 425 non-profits
- 2,066 for-profits
- 259 faith based organizations
- 89 school districts



Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and improve performance management. In FY18 there were 31 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.

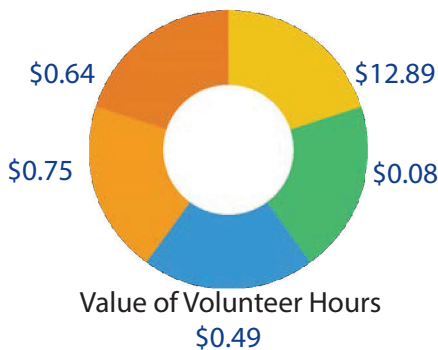


There were 720,379 hours of volunteer time donated to CAAs in South Carolina.

Community Action Agencies leverage several other federal, state, local and other private funds.

For every \$1 of CSBG, South Carolina's CAAs leveraged \$14.86 from federal, state, local and private sources, including the value of volunteer hours.

- \$10,591,955 in CSBG funds were allocated in support of CAAs in South Carolina in FY18.
- Including all leveraged funds, South Carolina had \$162,767,129 available to the CAA network to improve the lives of people with low incomes in FY18.



13 CAAs in South Carolina also operate the Low Income Home Energy Assistance Program (LIHEAP).



8 CAAs in South Carolina also operate the Weatherization Assistance Program (WAP).



12 CAAs in South Carolina also operate a Head Start Program.

From the South Carolina FFY 2018 Community Services Block Grant

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social/behavioral development, and civic engagement and community involvement.

EMPLOYMENT

2,990 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

EDUCATION

40,916 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

HOUSING

9,562 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

INCOME

3,655 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.

CIVIC ENGAGEMENT

4,502 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.

HEALTH

45,825 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.
