## WHO WE SERVE...



### For FFY2018:

There were 20 CAAs, serving 313,502 people with low incomes who were living in 138,475 families.

CAAs served 35,086 people who lacked healthcare, 94,942 people who reported having a disability, 45,938 senior citizens, 111,429 children living in poverty, and 3,238 veterans.



## WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

- Goal 1** - Individuals and families with low incomes are stable and achieve economic security.
- Goal 2** - Communities where people with low incomes live are healthy and offer economic opportunity.
- Goal 3** - People with low incomes are engaged and active in building opportunities in communities.

## What kinds of RESOURCES do CAAs have?

Tennessee Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 1,931 non-profits
- 2,258 for-profits
- 1,221 faith based organizations
- 236 school districts



Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and improve performance management. In FY18 there were 20 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.

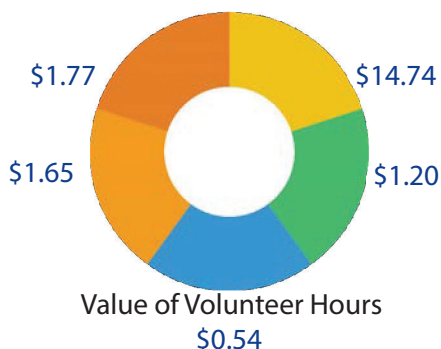


There were 1,156,264 hours of volunteer time donated to CAAs in Tennessee.

## Community Action Agencies leverage several other federal, state, local and other private funds.

For every \$1 of CSBG, Tennessee's CAAs leveraged \$19.89 from federal, state, local and private sources, including the value of volunteer hours.

- \$15,620,698 in CSBG funds were allocated in support of CAAs in Tennessee in FY18.
- Including all leveraged funds, Tennessee had \$318,007,166 available to the CAA network to improve the lives of people with low incomes in FY18.



19 CAAs in Tennessee also operate the Low Income Home Energy Assistance Program (LIHEAP).



11 CAAs in Tennessee also operate the Weatherization Assistance Program (WAP).



13 CAAs in Tennessee also operate a Head Start Program.

# FFY 2018 STATE CSBG FACTSHEET | TENNESSEE

From the Tennessee FFY 2018 Community Services Block Grant

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social/behavioral development, and civic engagement and community involvement.

## EMPLOYMENT

24,450 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

## EDUCATION

46,838 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

## HOUSING

24,155 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.



## INCOME

3,163 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.

## HEALTH

315,180 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.

## CIVIC ENGAGEMENT

158,791 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.
