

**Kansas Weatherization Grant Difference
Quick Cheat Sheet Effective 7-1-21 for 2021 Grants**

There has been a request from the field for a quick cheat sheet of the main differences between allowable and disallowed measures for the different current Kansas Weatherization Grants. Please note that this is a quick reference sheet for internal uses only and is only effective for the current program year. The official Grant Documents for each grant shall supersede this document.
