Legislative Update

Biden Actions & Appointments

- Rollback earlier rules
 - Repeal or delay executive rules such as requiring decennial HHS rule review
- HHS Secretary
 - Nominee Xavier Becerra, California's attorney general, awaits Senate confirmation
- Acting HHS Secretary
 - Norris Cochran, HHS deputy assistant secretary of budget, is serving as acting HHS secretary for the second time. He also served as acting secretary in 2017.
- Deputy HHS Secretary
 - Amanda Palm, alum of the Wisconsin
 Department of Health Services & the Obama
 Admin
- Acting Assistant Secretary
 - Ben Goldhaber, with HHS since 1999,
 previously served as the Deputy Assistant
 Secretary for Administration.



Legislative Update COVID Relief Bill

- Democrats move ahead without Republican support
 - Dems instead plan to pass it solely through reconciliation, which only requires 51 Senate votes
- \$1.9 Trillion COVID Relief Bill
 - Contains \$1,400 checks, unemployment relief, child tax credits, vaccine funds, and subsidies for rent, food, and public transit.
 - Contains a minimum wage increase to \$15/hr and \$4.5 billion for LIHEAP.
 - Dems attempting to pass it "by the second or third week of March."





ANNUAL REPORT UPDATE

FY20 Regular CSBG Annual Report Update

Module 1:

- OCS is postponing the implementation of the new data points. You will be using the same form as last year for this year's submission.
 - The form is posted to the NASCSP website.

Module 2-4:

- We are waiting for FY19 data to be finalized to be able to release the SmartForms.
 - XMLs will not change, but states using a system will need the updated 'additional fields'.



FY20 Regular CSBG Annual Report Update

- CSBG Annual Report (FY20)
 - OCS stated that there will be a deadline extension to April 30, 2021
 - OLDC should be open in early March.
 - OCS will release a DCL on CSBG reporting.
 - OCS is holding a webinar on March 3rd, 2 p.m. 3

All CSBG CARES and Disaster activities will be included in the regular CSBG Annual Report

Supplemental Report Update

- There will be a separate Module 1, 2 and 4 for both CSBG CARES and Disaster Supplemental funds each.
- Module 1 reduced number of questions and modified
- Module 2 only expenditures and allocated resources (Sections A and C)
- Module 4 only services (Section B)

Supplemental Report Update

- Module 2 only expenditures and allocated resources (Sections A and C)
 - OCS is adding a narrative opportunity

- Module 4 only services (Section B)
 - OCS is adding two services:
 - Direct Financial Assistance
 - PPE

Supplemental Report Update

- States will be able to use SmartForms or their state systems to submit the supplemental reports.
- Supplemental reports will be due May 30, 2021 (this is a Sunday).

CSBG Performance Management Website

- The CSBG Performance Management Website development has been completed for state level CSBG data.
 - We are waiting further guidance on the roll-out timeline of the website.
- States will be able to pull reports with graphs and charts and query the system for information found in state plans and Module 1.
- The website will be released only to states first prior to the general public.
- There will eventually be a public and private side.
