WHO WE SERVE...



For FFY 2019:

There were 25 CAAs, serving 219,065 people with low incomes who were living in 135,623 families.

CAAs served 47,665 people who lacked healthcare, 19,485 people who reported having a disability, 25,468 senior citizens, 56,463 children living in poverty, and 3,307 veterans.

WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

- Goal 1** - Individuals and families with low incomes are stable and achieve economic security.
- Goal 2** - Communities where people with low incomes live are healthy and offer economic opportunity.
- Goal 3** - People with low incomes are engaged and active in building opportunities in communities.

What kind of RESOURCES do CAAs have?

New Jersey Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 923 non-profits
- 758 for-profits
- 316 faith based organizations
- 288 school districts



Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and improve performance management. In FY19 there were 8 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.

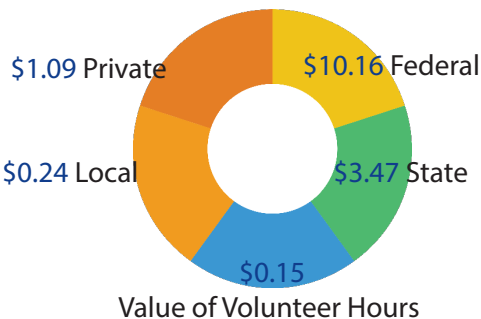


There were 355,216 hours of volunteer time donated to CAAs in New Jersey.

Community Action Agencies leverage several other federal, state, local and other private funds.

For every \$1 of CSBG, New Jersey's CAAs leveraged \$15.11 from federal, state, local and private sources, including the value of volunteer hours.

- \$17,439,517 in CSBG funds were allocated in support of CAAs in New Jersey in FY19.
- Including, all leveraged funds New Jersey had \$278,303,729 available to the CAA network to improve the lives of people with low incomes in FY19.

From the New Jersey FFY 2019 Community Services Block Grant Annual Report

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social behavioral development, and civic engagement and community involvement.

EMPLOYMENT

3,096 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

EDUCATION

39,331 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

HOUSING

27,871 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

INCOME

4,110 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.



CIVIC ENGAGEMENT

985 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.

HEALTH

177,082 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.
