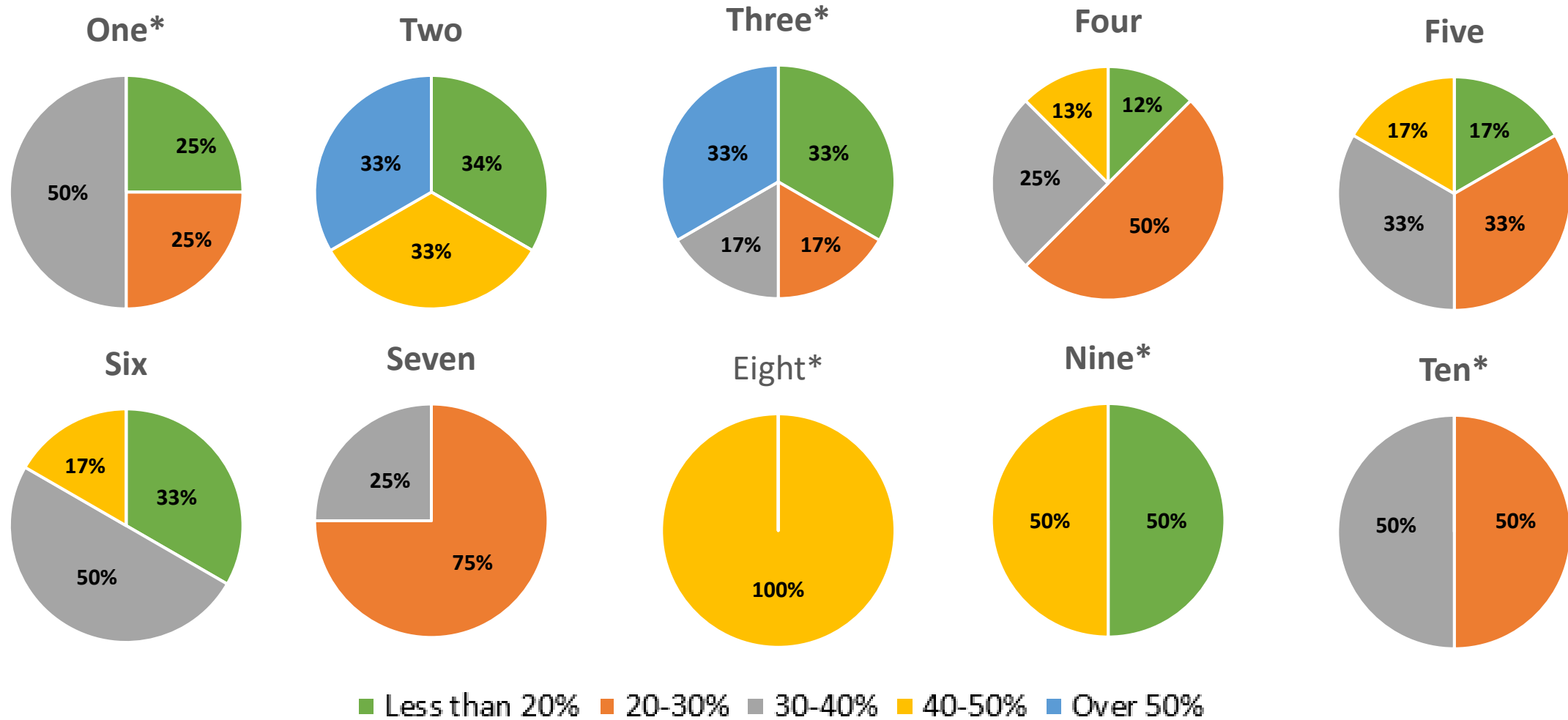

# CSBG CARES Drawdown

Percentage remaining to spend	Number of States (including Small States)	Number of States (not including Small States)
Over 50% remains	10 States (April – 14)	4 States (April – 7)
40-50% remains	11 States (April – 10)	8 States (April – 7)
30-40% remains	12 States (April – 11)	10 States (April – 9)
20-30% remains	12 States (April – 11)	11 States (April – 12)
Less than 20% remains	8 States (April – 6)	8 States (April – 6)
<b>Total Remaining Balance</b>	<b>\$305,723,197 (18 million ↓)</b>	<b>\$268,513,283 (23 million ↓)</b>

Number of States	Percentage of Change from April to May
2 states	Greater than 26% reduction

# State Roles and Responsibilities

It falls to the state to determine allowability and eligibility parameters

- Eligibility ***does not*** have to be ***directly*** tied to COVID-19 infection
- Everyone has been ***impacted*** by COVID at this point
- A Few Examples:
  - Inflation-Gas and Food Price Increases
  - Missed Wages/Unemployment/Reduced Hours
  - Child Care Closures and Price Increases
  - Deaths in the Family

# State Roles and Responsibilities

States can and ***should*** be flexible

- Expediting Contract Amendments/Modifications
  - Work Plans
  - Budgets
- Abbreviated Community Needs Assessments and/or CAP plans
- Advances vs Reimbursements

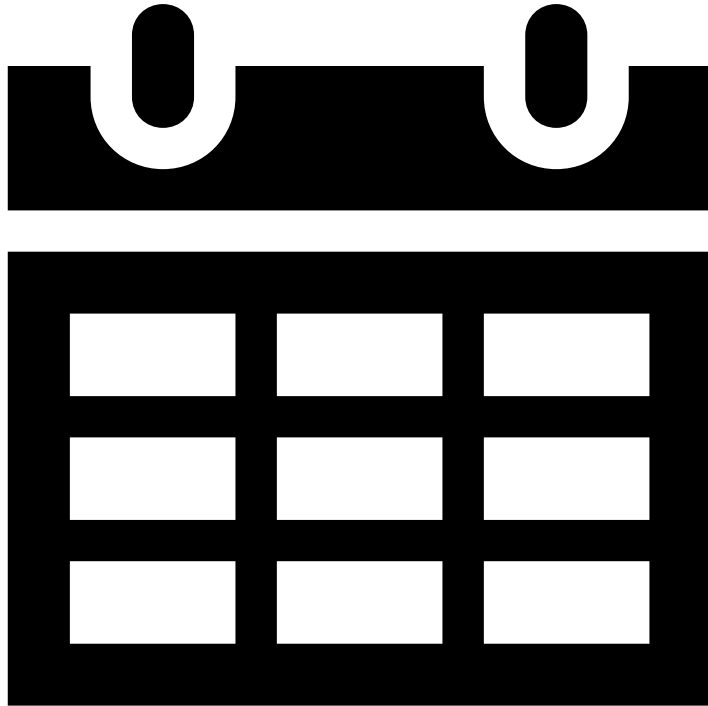
