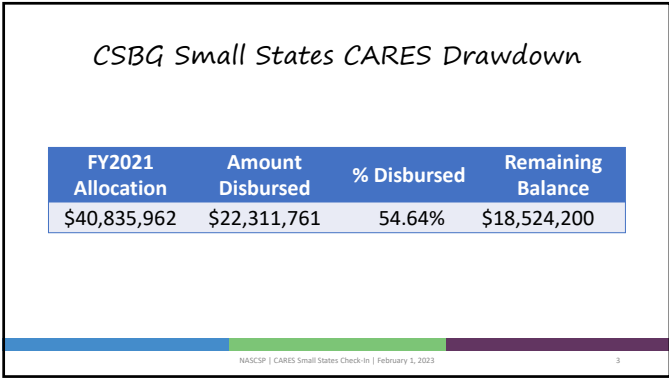


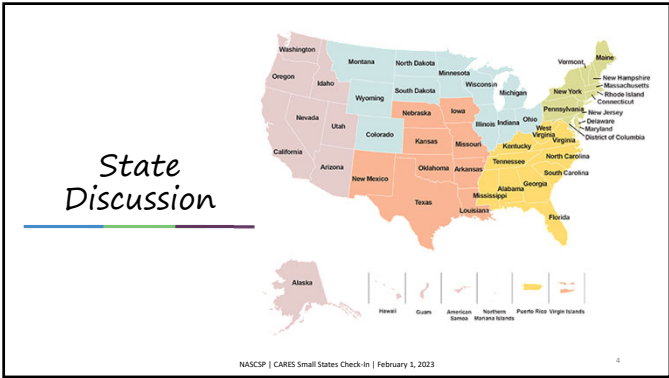

State Roles and Responsibilities

It generally falls to the state to determine allowability and eligibility parameters

- Eligibility **does not** have to be **directly** tied to COVID-19 infection
- Everyone has been **impacted** by COVID at this point
- A Few Examples:
 - Inflation-Gas and Food Price Increases
 - Missed Wages/Unemployment/Reduced Hours
 - Child Care Closures and Price Increases
 - Deaths in the Family

- Advances vs Reimbursements

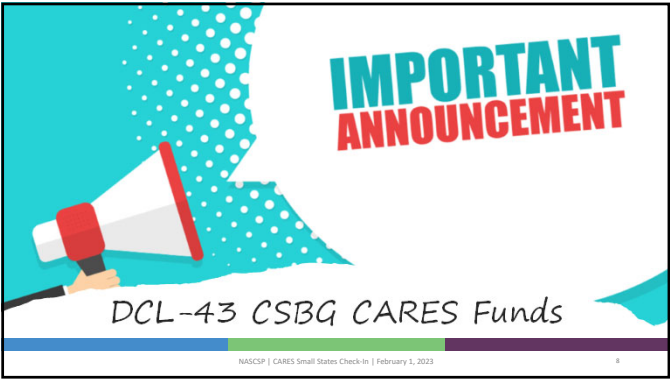

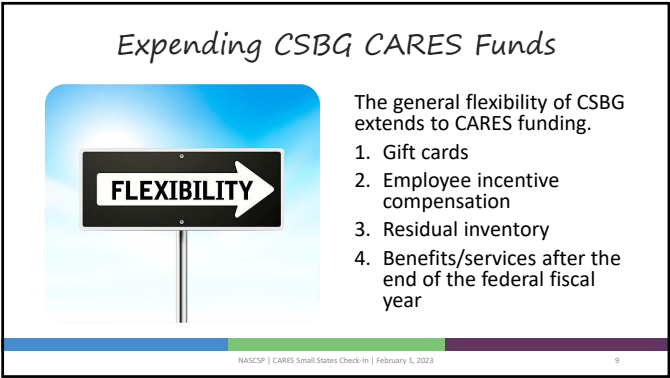

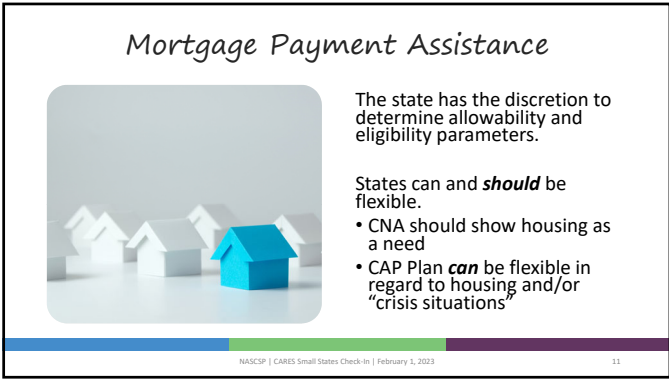
