## WHO WE SERVED...



### For FFY 2021:

There were 35 CAAs, serving 555,614 people with low incomes who were living in 278,410 families.

CAAs served 8,368 people who lacked healthcare, 86,373 people who reported having a disability, 105,265 senior citizens, 181,435 children living in poverty, and 1,760 veterans and active military persons.



## WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

- Goal 1** - Individuals and families with low incomes are stable and achieve economic security.
- Goal 2** - Communities where people with low incomes live are healthy and offer economic opportunity.
- Goal 3** - People with low incomes are engaged and active in building opportunities in communities.

Illinois' Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 2,141 non-profits
- 1,317 for-profits
- 874 faith-based organizations
- 601 school districts



There were 451,807 hours of volunteer time donated to CAAs in Illinois.

## What kind of RESOURCES do CAAs have?

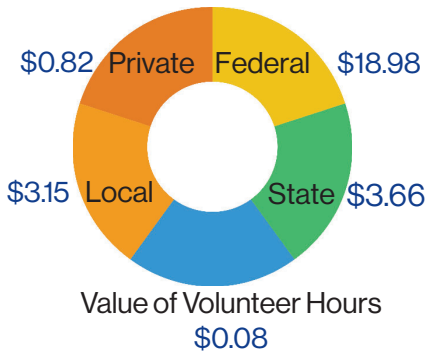
Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and improve performance management. In FY21, there were 39 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.



Community Action Agencies leverage several other federal, state, local, and other private funds.

For every \$1 of CSBG, Illinois' CAAs leveraged \$26.69 from federal, state, local, and private sources, including the value of volunteer hours.

- \$39,596,385 in CSBG funds were allocated in support of CAAs in Illinois in FY21.
- Including all leveraged funds, Illinois had \$1,093,309,065 available to the CAA network to improve the lives of people with low incomes in FY21.



32 CAAs in Illinois also operate the Low Income Home Energy Assistance Program (LIHEAP).



31 CAAs in Illinois also operate the Weatherization Assistance Program (WAP).



16 CAAs in Illinois also operate a Head Start Program.

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social behavioral development, and civic engagement and community involvement.

## EMPLOYMENT

20,365 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

## EDUCATION

94,924 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

## INCOME & ASSETS

19,357 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.

## CIVIC ENGAGEMENT

21,155 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.

## HOUSING

366,566 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

## HEALTH

437,616 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.
