## WHO WE SERVED...



### For FFY 2021:

There were 25 CAAs, serving 30,589 people with low incomes who were living in 18,582 families.

CAAs served 5,627 people who lacked healthcare, 2,100 people who reported having a disability, 4,544 senior citizens, 10,370 children living in poverty, and 158 veterans and active military persons.



## WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

- Goal 1** - Individuals and families with low incomes are stable and achieve economic security.
- Goal 2** - Communities where people with low incomes live are healthy and offer economic opportunity.
- Goal 3** - People with low incomes are engaged and active in building opportunities in communities.

New Jersey's Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

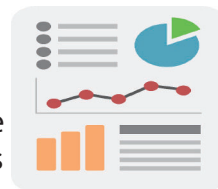
- 908 non-profits
- 769 for-profits
- 264 faith-based organizations
- 206 school districts



There were 163,440 hours of volunteer time donated to CAAs in New Jersey.

## What kind of RESOURCES do CAAs have?

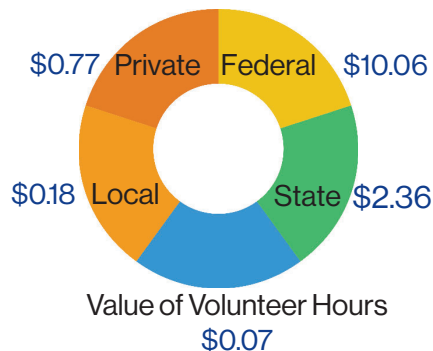
Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and improve performance management. In FY21, there were 5 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.



Community Action Agencies leverage several other federal, state, local, and other private funds.

For every \$1 of CSBG, New Jersey's CAAs leveraged \$13.44 from federal, state, local, and private sources, including the value of volunteer hours.

- \$17,114,977 in CSBG funds were allocated in support of CAAs in New Jersey in FY21.
- Including all leveraged funds, New Jersey had \$221,112,688 available to the CAA network to improve the lives of people with low incomes in FY21.

5 CAAs in New Jersey also operate the Weatherization Assistance Program (WAP).

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social behavioral development, and civic engagement and community involvement.

## EMPLOYMENT

332 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

## EDUCATION

2,083 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

## HOUSING

8,120 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

## INCOME & ASSETS

895 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.

## HEALTH

7,721 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.

## CIVIC ENGAGEMENT

The civic engagement and community involvement domain includes outcomes such as increasing leadership skills, and improving social networks.
