WHO WE SERVED...



For FFY 2021:

There were 43 CAAs, serving 442,501 people with low incomes who were living in 229,628 families.

CAAs served 14,944 people who lacked healthcare, 33,504 people who reported having a disability, 57,115 senior citizens, 100,214 children living in poverty, and 9,882 veterans and active military persons.



WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

- Goal 1** - Individuals and families with low incomes are stable and achieve economic security.
- Goal 2** - Communities where people with low incomes live are healthy and offer economic opportunity.
- Goal 3** - People with low incomes are engaged and active in building opportunities in communities.

Pennsylvania's Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 2,896 non-profits
- 2,072 for-profits
- 1,123 faith-based organizations
- 477 school districts



There were 665,378 hours of volunteer time donated to CAAs in Pennsylvania.

What kind of RESOURCES do CAAs have?

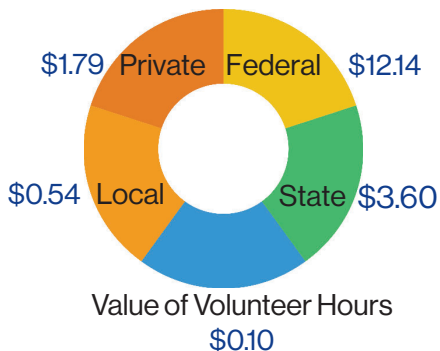
Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and improve performance management. In FY21, there were 44 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.



Community Action Agencies leverage several other federal, state, local, and other private funds.

For every \$1 of CSBG, Pennsylvania's CAAs leveraged \$18.17 from federal, state, local, and private sources, including the value of volunteer hours.

- \$47,392,516 in CSBG funds were allocated in support of CAAs in Pennsylvania in FY21.
- Including all leveraged funds, Pennsylvania had \$903,656,932 available to the CAA network to improve the lives of people with low incomes in FY21.

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social behavioral development, and civic engagement and community involvement.

EMPLOYMENT

6,918 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

EDUCATION

55,013 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

INCOME & ASSETS

30,682 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.

HOUSING

93,129 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

HEALTH

189,612 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.

CIVIC ENGAGEMENT

11,254 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.
