The Division of CD & Housing provides a policy, administration and implementation framework for a range of housing development, preservation and service programs. These programs provide targeted assistance to serve populations across the Commonwealth, focusing on meeting the housing needs of low-income persons, persons experiencing homelessness and at risk of becoming homeless, and special needs populations. Areas of emphasis include affordable housing (homeownership and rental opportunities), housing preservation, housing for special needs populations and preventing and ending homelessness.

The selected individual will ensure effective collaboration efforts with aligning programs to assure sharing of knowledge, decisions, appropriate integrations, and resources.
