

### Fiscal Responsibility Act of 2023

- Grant recipient awards funded by the Coronavirus Aid, Relief, and Economic Security Act (CARES) for the small states, are <u>NOT</u> subject to this rescission.
- Grant recipient awards have already been legally obligated by the federal government and therefore will not be rescinded by this bill.

### CSBG CARES Overview

- CSBG CARES funds expire on September 30, 2022
  - Small States have the ability to obligate their second installment of CARES funds through September 30, 2023
    - THERE IS NO CARRYOVER OF CSBG CARES FUNDS
