2017 RFP Process for \$150,000 in Innovation Funding Available

• 17 applications were received, requesting \$745,000 for the \$150,000 that was available.

AWARDED AGENCIES

- Community Food Forests perennial herbs, greens, berries, vegetables and fruit trees near low-income neighborhoods to create 2 sustainable, edible gathering spaces.
- BikePlus A year-round program that supports bicycle riding in all seasons for transportation access and health benefits.
- A Do It Yourself (DIY) Tax Preparation Training weekly sessions during income tax season February 1 through April 15.
- DRIVE a lease program for low-income participants, who wouldn't otherwise be eligible to lease-to-own a new reliable vehicle. Leases are made at zero percent interest.

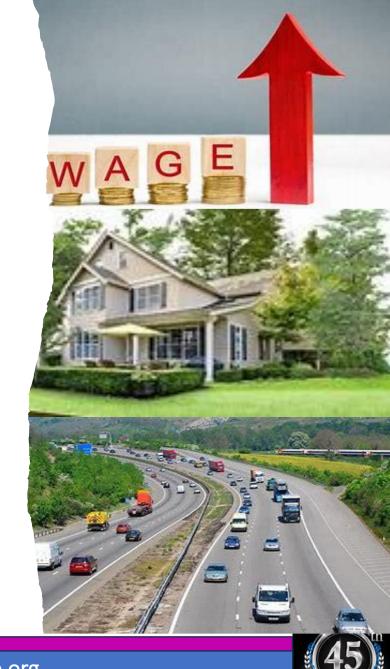

Leased vehicles-

- Partnership with local dealer- started with three- now up to 8
- Eligibility: CSBG income guidelines and ability to pay monthly payment/ insurance
- Monthly visits: Look at the vehicle, provide education on maintenance, address budget concerns, referrals, etc.





Donated Vehicles-

- Marketing Plans
- Outreach/Advertising
- Partnerships- local repair shops, towing companies, volunteers
- Assess for safety/appropriate for sale
- Required repair investment
- Sell or scrap? Evaluate
- In 2018, 3 donated vehicles. 2019, 25 donations.





Donated Vehicles-



- To date, we have received over 80 donated vehicles.
- Most of these have come through our advertising efforts, outreach/presentations and word of mouth.
- Approximately 50% of those donated cars have been resold to clients. The remaining are scrapped and we utilize those funds to do necessary repairs on those we sell.





Other Services:

 \$800 cap, focused on safety repairs
 (tires, brakes, transmission, etc.)

THE 5 MOST IMPORTANTCAR MAINTENANCE TIPS

Basic vehicle maintenance keeps your car running smoothly and can prevent breakdowns and even accidents. Follow these car maintenance tips to keep your vehicle in good working order:



TAKE CARE OF YOUR TIRES

Tires in poor condition pose a dangerous threat to the safety of you and your loved ones.

Here are a few items to be mindful of:

- Tire pressure Check your tires' pressure at least once a month. Underinflated tires affect your fuel efficiency and cost you money.
- Tire rotation Rotate the tires every
 5 000-8 000 miles
- Tire condition Inspect your tires regularly for any signs of bulges or bald spots. If you spot any of these danger signs, have the tire replaced as soon as possible.
- Uneven wear Uneven wear on a tire indicates wheel alignment problems.
 Have the wheels aligned properly as soon as possible.
- Spare tire Check your spare tire at least once a month to ensure it's usable if you find yourself having to replace a flat.



TIP #3: CHECK THE BATTERY

At least every 5,000 miles, check and refill your fluids.

You can have your mechanic check the battery or do it yourself via a car battery tester



TIP #4: CHECK THE LIGHTS

Check your exterior and interior lights regularly. Besides the headlights, make sure your indicators, brake lights and fog lights are in good working order.



TIP #5: GET AN ANNUAL INSPECTION

At least once a year, or according to the manufacturer's recommendations, take your car in for servicing. Your mechanic will check the fuel filters, brake pads and spark plugs and replace them if needed.

The mechanic will also flush the radiator to get rid of the old fluid and replace it with new fluid.

Other annual maintenance includes checking the ABS sensor, timing belt and fuel pressure regulator.

Ruby uses a wheelchair and was looking for transportation, having not been able to drive for the last few years due to her health.

Ruby has regular appointments, and it has been difficult for her to get out of her home without a modified vehicle. Each time Ruby wanted to leave the house, her husband needed to lift her and then her wheelchair in and out of their truck.

Because of the generous donation of this accessible van, Ruby is now able to get into the vehicle on the electric ramp where she is then secured safely. With the accessibility of the vehicle, Ruby is able to drive using hand controls. Having been unable to drive for many years, this has provided her with the vehicle to start driving again!

Ruby and her husband praise Tri-CAP's DRIVE program which helps provide low-cost transportation to families with limited income. This purchase ended with double joy; not only was it a good quality well-maintained vehicle, but it is also accessible for both entering the vehicle AND driving it. Ruby was so grateful and overwhelmed to have this opportunity to purchase exactly what they needed, and Tri-CAP was so happy to be able to be a part of this process.
