WHO WE SERVED...



For FFY 2019:

There were 19 CAAs, serving 120,285 people with low incomes who were living in 58,982 families.

CAAs served 11,517 people who lacked healthcare, 27,272 people who reported having a disability, 9,266 senior citizens, 47,047 children living in poverty, and 1,901 veterans and active military persons.



WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

- Goal 1** - Individuals and families with low incomes are stable and achieve economic security.
- Goal 2** - Communities where people with low incomes live are healthy and offer economic opportunity.
- Goal 3** - People with low incomes are engaged and active in building opportunities in communities.

Missouri's Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 842 non-profits
- 936 for-profits
- 462 faith-based organizations
- 361 school districts



There were 985,534 hours of volunteer time donated to CAAs in Missouri.

What kind of RESOURCES do CAAs have?

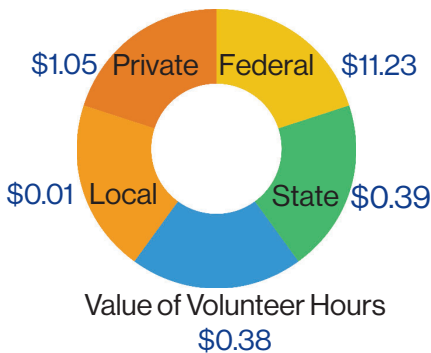
Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and improve performance management. In FY19, there were 42 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.



Community Action Agencies leverage several other federal, state, local, and other private funds.

For every \$1 of CSBG, Missouri's CAAs leveraged \$13.06 from federal, state, local, and private sources, including the value of volunteer hours.

- \$18,876,086 in CSBG funds were allocated in support of CAAs in Missouri in FY19.
- Including all leveraged funds, Missouri had \$258,160,805 available to the CAA network to improve the lives of people with low incomes in FY19.

14 CAAs in Missouri also operate a Head Start Program.

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social behavioral development, and civic engagement and community involvement.

EMPLOYMENT

1,657 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

EDUCATION

22,226 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

INCOME & ASSETS

4,147 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.

CIVIC ENGAGEMENT

9,183 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.

HOUSING

14,412 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

HEALTH

45,844 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.
