WHO WE SERVED...



For FFY 2019:

There were 9 CAAs, serving 49,712 people with low incomes who were living in 23,759 families.

CAAs served 9,772 people who lacked healthcare, 8,448 people who reported having a disability, 8,183 senior citizens, 17,379 children living in poverty, and 2,444 veterans and active military persons.



WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

Nebraska's Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 957 non-profits
- 1,137 for-profits
- 532 faith-based organizations
- 342 school districts



There were 538,098 hours of volunteer time donated to CAAs in Nebraska.

improve performance management. In FY19, there were 12 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.

Community Action Agencies leverage several other federal, state, local, and other private funds.

For every \$1 of CSBG, Nebraska's CAAs leveraged \$18.26 from federal, state, local, and private sources, including the value of volunteer hours.

From Nebraska's FFY 2019 Community Services Block Grant Annual Report

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social behavioral development, and civic engagement and community involvement.

EMPLOYMENT

1,041 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

EDUCATION

15,448 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

INCOME & ASSETS

4,441 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.



CIVIC ENGAGEMENT

1,742 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.

HOUSING

8,205 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

HEALTH

51,134 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.
