#### WHO WE SERVED...



## For FFY 2019:

There were 6 CAAs, serving 95,699 people with low incomes who were living in 54,740 families.

CAAs served 6,302 people who lacked healthcare, 3,117 people who reported having a disability, 14,064 senior citizens, 25,730 children living in poverty, and 1,071 veterans and active military persons.



# WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

New Mexico's Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 462 non-profits
- 445 for-profits

- 197 faith-based organizations
- 73 school districts



There were 231,463 hours of volunteer time donated to CAAs in New Mexico.

Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and

improve performance management. In FY19, there was 1 ROMA professional available in the network to help agencies with planning, reporting, data analysis and evaluation.


#### Community Action Agencies leverage several other federal, state, local, and other private funds.

For every \$1 of CSBG, New Mexico's CAAs leveraged \$11.85 from federal, state, local, and private sources, including the value of volunteer hours.

- \$3,670,697 in CSBG funds were allocated in support of CAAs in New Mexico in FY19.
- Including all leveraged funds, New Mexico had
  \$45,479,805 available to the CAA network to improve the

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social behavioral development, and civic engagement and community involvement.

# **EMPLOYMENT**

1,516 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

## **EDUCATION**

35,185 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

# **INCOME & ASSETS**

19,356 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.



# **CIVIC ENGAGEMENT**

3,480 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.

## HOUSING

2,688 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

# HEALTH

61,928 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.
