### WHO WE SERVED...



## For FFY 2019:

There were 49 CAAs, serving 534,248 people with low incomes who were living in 378,285 families.

CAAs served 62.613 people who lacked healthcare, 42,349 people who reported having a disability, 23,995 senior citizens, 305,320 children living in poverty, and 4,843 veterans and active military persons.



## WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

New York's Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 1,535 non-profits
- 750 for-profits
- 398 faith-based organizations
- 556 school districts



There were 901,912 hours of volunteer time donated to CAAs in New York.

Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and

improve performance management. In FY19, there were 65 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.

Community Action Agencies leverage several other federal, state, local, and other private funds.

For every \$1 of CSBG, New York's CAAs leveraged \$19.73 from federal, state, local, and private sources, including the value of volunteer hours.

- \$58,292,609 in CSBG funds were allocated in support of CAAs in New York in FY19.
- Including all leveraged funds, New York had \$1,200,958,513 available to the CAA network to improve the lives of people with low incomes in FY19.

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social behavioral development, and civic engagement and community involvement.

## **EMPLOYMENT**

89,350 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

### **EDUCATION**

200,944 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

## **INCOME & ASSETS**

7,741 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.



## **CIVIC ENGAGEMENT**

7,399 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.

### HOUSING

33,765 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

## HEALTH

247,562 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.
