WHO WE SERVED...



#### For FFY 2020:

There were 4 CAAs, serving 72,556 people with low incomes who were living in 18,346 families.

CAAs served 2,064 people who lacked healthcare. 4,414 people who reported having a disability, 5,097 senior citizens, 11,109 children living in poverty, and 202 veterans and active military persons.

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals: What kind of

with low incomes are stable and achieve economic security. Goal 2 - Communities where people with low incomes live are healthy and offer economic opportunity. Goal 3 - People with low incomes are engaged and active in building opportunities in communities.

Goal 1 - Individuals and families

Hawaii's Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 224 non-profits
- 190 for-profits
- 40 faith-based organizations
- 12 school districts



a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and

improve performance management. In FY20, there was 1 ROMA professional available in the network to help agencies with planning, reporting, data analysis and evaluation.





There were 99,818 hours of volunteer time donated to CAAs in Hawaii.

Community Action Agencies leverage several other federal, state, local, and other private funds.

For every \$1 of CSBG, Hawaii's CAAs leveraged \$12.36 from federal, state, local, and private sources, including the value of volunteer hours.

- \$3,740,638 in CSBG funds were allocated in support of CAAs in Hawaii in FY20.

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social behavioral development, and civic engagement and community involvement.

#### **EMPLOYMENT**

392 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

#### **EDUCATION**

9,948 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

### **INCOME & ASSETS**

2,546 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.



# **CIVIC ENGAGEMENT**

1,218 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.

#### **HOUSING**

1,886 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

# **HEALTH**

8,355 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.
