WHO WE SERVED...



For FFY 2020:

There were 10 CAAs, serving 123,035 people with low incomes who were living in 74,718 families.

CAAs served 4,869 people who lacked healthcare, 21,274 people who reported having a disability, 20,990 senior citizens, 33,474 children living in poverty, and 671 veterans and active military persons.

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

Goal 1 - Individuals and families with low incomes are stable and achieve economic security. Goal 2 - Communities where people with low incomes live are healthy and offer economic opportunity. Goal 3 - People with low incomes are engaged and active in building opportunities in communities.

Maine's Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 786 non-profits
- 421 for-profits
- 180 faith-based organizations
- 242 school districts







There were 431,770 hours of volunteer time donated to CAAs in Maine.

What kind of RESOURCES

Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and

improve performance management. In FY20, there were 12 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.



Community Action Agencies leverage several other federal, state, local, and other private funds.

For every \$1 of CSBG, Maine's CAAs leveraged \$47.95 from federal, state, local, and private sources, including the value of volunteer hours.

- \$4,786,658 in CSBG funds were allocated in support of CAAs in Maine in FY20.

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social behavioral development, and civic engagement and community involvement.

EMPLOYMENT

711 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

EDUCATION

10,212 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

INCOME & ASSETS

1,692 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.



CIVIC ENGAGEMENT

765 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.

HOUSING

17,473 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

HEALTH

45,494 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.
