WHO WE SERVED...



For FFY 2020:

There were 33 CAAs, serving 355,982 people with low incomes who were living in 152,910 families.

CAAs served 10,079 people who lacked healthcare, 62,931 people who reported having a disability, 56,285 senior citizens, 118,537 children living in poverty, and 10,019 veterans and active military persons.

WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

- Goal 1** - Individuals and families with low incomes are stable and achieve economic security.
- Goal 2** - Communities where people with low incomes live are healthy and offer economic opportunity.
- Goal 3** - People with low incomes are engaged and active in building opportunities in communities.

Minnesota's Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 1,969 non-profits
- 4,093 for-profits
- 557 faith-based organizations
- 573 school districts



There were 662,343 hours of volunteer time donated to CAAs in Minnesota.

What kind of RESOURCES do CAAs have?

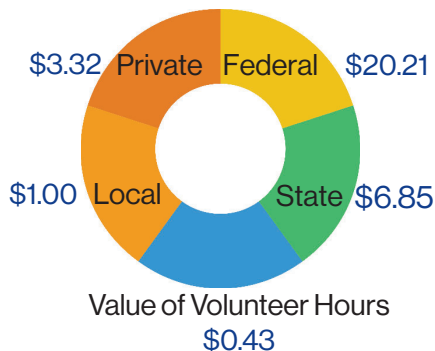
Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and improve performance management. In FY20, there were 15 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.



Community Action Agencies leverage several other federal, state, local, and other private funds.

For every \$1 of CSBG, Minnesota's CAAs leveraged \$31.81 from federal, state, local, and private sources, including the value of volunteer hours.

- \$11,239,244 in CSBG funds were allocated in support of CAAs in Minnesota in FY20.
- Including all leveraged funds Minnesota had \$364,011,147 available to the CAA network to improve the lives of people with low incomes in FY20.



21 CAAs in Minnesota also operate the Low Income Home Energy Assistance Program (LIHEAP).



18 CAAs in Minnesota also operate the Weatherization Assistance Program (WAP).



21 CAAs in Minnesota also operate a Head Start Program.

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social behavioral development, and civic engagement and community involvement.

EMPLOYMENT

2,105 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

EDUCATION

46,513 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

HOUSING

37,572 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

INCOME & ASSETS

10,422 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.

HEALTH

102,425 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.

CIVIC ENGAGEMENT

4,723 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.
