WHO WE SERVED...



For FFY 2020:

There were 5 CAAs, serving 96,125 people with low incomes who were living in 39,705 families.

CAAs served 8.634 people who lacked healthcare, 17,732 people who reported having a disability, 17,399 senior citizens, 25,109 children living in poverty, and 2,841 veterans and active military persons.



WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

New Hampshire's Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 500 non-profits
- 533 for-profits
- 119 faith-based organizations
- 71 school districts



There were 545,993 hours of volunteer time donated to CAAs in New Hampshire.

Community Action Agencies leverage several other federal, state, local, and other private funds.

For every \$1 of CSBG, New Hampshire's CAAs leveraged \$31.85 from federal, state, local, and private sources, including the value of volunteer hours.

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social behavioral development, and civic engagement and community involvement.

EMPLOYMENT

1,712 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

EDUCATION

3,824 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

INCOME & ASSETS

182 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.



CIVIC ENGAGEMENT

381 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.

HOUSING

22,571 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

HEALTH

17,555 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.
