WHO WE SERVED...



For FFY 2020:

There were 20 CAAs, serving 332,165 people with low incomes who were living in 169,953 families.

CAAs served 32,610 people who lacked healthcare, 109,228 people who reported having a disability, 48,520 senior citizens, 110,209 children living in poverty, and 2,765 veterans and active military persons.

WHAT IS CSBG?

The Community Services Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and conditions of poverty under three national goals:

- Goal 1** - Individuals and families with low incomes are stable and achieve economic security.
- Goal 2** - Communities where people with low incomes live are healthy and offer economic opportunity.
- Goal 3** - People with low incomes are engaged and active in building opportunities in communities.

Tennessee's Community Action Agencies are centrally located to serve their communities. For maximum impact, they partnered with:

- 1,999 non-profits
- 2,279 for-profits
- 1,178 faith-based organizations
- 242 school districts



There were 908,053 hours of volunteer time donated to CAAs in Tennessee.

What kind of RESOURCES do CAAs have?

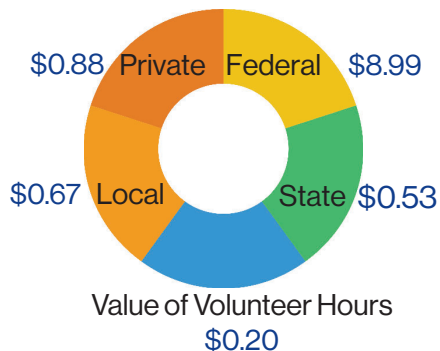
Community Action Agencies utilize a Results Oriented Management and Accountability system that is strategically designed to ensure accountability and improve performance management. In FY20, there were 17 ROMA professionals available in the network to help agencies with planning, reporting, data analysis and evaluation.



Community Action Agencies leverage several other federal, state, local, and other private funds.

For every \$1 of CSBG, Tennessee's CAAs leveraged \$11.26 from federal, state, local, and private sources, including the value of volunteer hours.

- \$33,398,010 in CSBG funds were allocated in support of CAAs in Tennessee in FY20.
- Including all leveraged funds Tennessee had \$401,441,590 available to the CAA network to improve the lives of people with low incomes in FY20.

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social behavioral development, and civic engagement and community involvement.

EMPLOYMENT

5,911 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

EDUCATION

41,729 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

HOUSING

56,293 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

INCOME & ASSETS

4,315 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.

HEALTH

150,579 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.

CIVIC ENGAGEMENT

2,660 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.
