OCS Pre-Monitoring Steps

Step 1: Engagement Letter

Request for supporting documentation

Step 2: Review of Documentation

- Verify state plan assurances
- Evaluate state monitoring of eligible entities
- Review Single Audit procedures for state and eligible entities

Step 3: Fiscal Analysis

Analysis of nonprofit eligible entities' financial position

Step 4: Coordinate with State CSBG Office

- Select eligible entities for a site visit
- Identify specific technical assistance needs of the state





On-Site Areas of Review









OCS Post-Monitoring Steps

Finalize Workpapers

Identify instances of notable practices, findings, and open items

Prepare Draft Report

- States respond within 30 Days
 - States are allowed to request an extension

Produce Final Report

- Incorporate state responses into the report
- Finalize Report 30 days
- Evaluate the response and determine next steps

Follow-Up

- Periodically check in to determine if any necessary corrective action was implemented
- Share observations that are not reportable with the state, if applicable


