For FFY 2021:

There were 15 CAAs, serving 739 people with low incomes who were living in 667 families.

CAAs served 23 people who lacked healthcare, 14 people who reported having a disability, 20 senior citizens, 390 children living in poverty, and 1 veteran. From American Samoa's FFY 2021 Community Services Block Grant Annual Report

- 5 faith-based organizations

There were 6,416 hours of volunteer time donated to CAAs in American Samoa.

Community Action Agencies leverage several other federal, state, local, and other private funds.

For every \$1 of CSBG, American Samoa's CAAs leveraged \$0.47 from federal, state, local, and private sources, including the value of volunteer hours.

Community Action Agencies utilize CSBG funds to address specific local needs through services and programs that address one or more of the core domains in which we work: employment, education and cognitive development, income, infrastructure and asset building, housing, health and social behavioral development, and civic engagement and community involvement.

EMPLOYMENT

1,552 outcomes were obtained in the employment domain. This includes outcomes such as obtaining and maintaining a job, increasing income, and obtaining benefits.

EDUCATION

23,085 outcomes were obtained in the education and cognitive development domain. This includes outcomes such as improved literacy skills, school readiness, and obtaining additional education and diplomas.

INCOME & ASSETS

2,824 outcomes were obtained in the income and asset building domain. This includes outcomes such as maintaining a budget, opening a savings account, increasing assets and net worth, and improving financial well-being.



CIVIC ENGAGEMENT

3,280 outcomes were obtained in the civic engagement and community involvement domain. This includes outcomes such as increasing leadership skills, and improving social networks.

HOUSING

25,091 outcomes were obtained in the housing domain. This includes outcomes such as obtaining and maintaining housing, avoiding eviction or foreclosure, and reducing energy burden.

HEALTH

89,192 outcomes were obtained in the health and social/behavioral development domain. This includes outcomes such as increasing nutrition skills, improving physical or mental health, and living independently.
