TO: Weatherization Assistance Program (WAP) Grantees, Subgrantees and Training Centers

DEADLINE EXTENDED: DOE has extended the submission deadline for E&I grant applications to October 11, 2024.

The U.S. Department of Energy's (DOE) Weatherization Assistance Program (WAP) has issued a \$36 million Funding Opportunity Announcement (FOA) entitled "WAP Enhancement & Innovation," with a maximum award amount of \$2 million. The FOA is available on the Clean Energy Infrastructure Funding Opportunity Exchange.

Title IV, Energy Conservation and Production Act, as amended, authorizes DOE to administer WAP (42 U.S.C.§ 6861, et. seq.). The Enhancement & Innovation (E&I) Program is governed by 42 U.S.C. 6861d and is funded on an annual basis by Congress through WAP appropriation. Eligible entities include existing WAP Grantees, WAP Subgrantees, and other nonprofit entities. The period of performance for each award is three (3) years.

This FOA seeks applications to expand the impact of DOE's existing residential weatherization programs by utilizing leveraged resources and enhanced community partnerships to perform deep energy retrofits of lowincome residential buildings and empower local community representation within the energy workforce. DOE seeks proposals that drive innovative approaches to program coordination and service delivery, while fostering the collaboration of dynamic and diverse teams.

These awards will enable deep energy retrofits of low-income housing in three (3) topic areas:

- 1) Multifamily Housing
- 2) Single family and Manufactured Housing
- 3) Workforce Development

Applicants are encouraged to use awarded E&I funds in conjunction with WAP formula awards and other funding sources to deploy demonstration projects that have potential to be scaled nationally, enhance the benefits realized by underserved communities, and ensure an equitable transition to a clean-energy economy.

Full Application Submission Deadline: 10/11/2024 5:00 PM ET
