

LIHEAP Weatherization Overview

The Low Income Home Energy Assistance Program (LIHEAP) helps maintain safe and healthy indoor temperatures by providing critical energy assistance services.

In addition to helping with heating and cooling bills and preventing home energy shutoffs, LIHEAP can be used to provide residential weatherization or other energy-related home repairs.

LIHEAP weatherization funds are commonly used to fund:

- home energy audits
- insulation
- major appliance replacements (e.g., heating/cooling systems and water tanks)
- energy efficient upgrades
- other energy-related minor repairs

How much LIHEAP can go to Wx?

- A maximum of **15 percent** of the LIHEAP grant can be spent on Weatherization without a waiver
- Can be increased to **25 percent** with a waiver by HHS, if certain conditions are met

Note:

- LIHEAP grantees are required to monitor LIHEAP weatherization funds
- LIHEAP grantees should consider coordinating with the DOE-funded agency to monitor subrecipients

DOE rules or HHS rules?

To streamline the eligibility process and reduce the burden on households, LIHEAP grant recipients may decide to use either LIHEAP weatherization rules or the U.S. Department of Energy, Weatherization Assistance Program (WAP) rules.

It's a question of **FLEXIBILITY...**

HHS Weatherization Flexibility

The LIHEAP grantee determines the specific rules and regulations that will govern use of LIHEAP funds for weatherization

- **Option 1:** Use LIHEAP funds under the same rules and guidelines as you would use DOE funds
- **Option 2:** Use primarily DOE rules, but with certain exceptions
- **Option 3:** Use LIHEAP exclusively LIHEAP rules –where LIHEAP grantee designs their own LIHEAP weatherization program

Weatherization in FY 2024

LIHEAP data on weatherized households:

- Number of households served with weatherization: **49,793**
- Total benefits – weatherization: **\$418,483,661**
- Average annual weatherization benefit per household: **\$8,404**
- Households assisted with equipment repair/replacement: **42,453**
- All states pass through LIHEAP with exceptions of MD, MA, MS, SD (*FL, HI not reporting*)



What is the National Community Action Foundation?




- NCAF is the federal advocate (501c4) for the national network of Community Action Agencies (CAAs) based in Washington, D.C.
 - **80% of WAP delivery organizations are CAAs**
 - **NCAF advances the local agency WAP priorities in Congress**
- NCAF was founded by CAAs in **1981** to prevent the dismantling of the CAA network.
- NCAF **works every day with Congress** to make sure CAAs and local WAP agencies have what they need to address the causes and conditions of poverty in almost every community.
- NCAF is governed by a **volunteer Board of Directors** which is composed of CAA executive directors from each region and an at-large representative.

The Visit: Talking Points

- The Weatherization Assistance Program (WAP) efficiently retrofits low-income homes, greatly improving residents' utility costs and health outcomes.
- WAP offers good local jobs and training needed to secure stable private sector work.
- All materials – materials, trucks, appliances – are purchased locally.
- By updating low-income homes, WAP helps preserve the local stock of affordable housing and keep seniors home.
- Because WAP ensures low-income homes have efficient energy use, more utility customers are able to keep up with their bills.
- (If talking to a Democrat): WAP reduces low income households' energy consumption.

The Visit: Points everyone appreciates



Affordable, safe housing

- Utility bills are lower and more stable
- Minor repairs keep deteriorating areas from becoming major, expensive problems
- Ventilation upgrades mean healthier air and healthier residents: DOE and state evaluations prove people with respiratory diseases and allergies experience fewer medical emergencies after WAP
- CAAs prioritize serving seniors and people with disabilities - allowing them to stay in their homes

The Visit: Points everyone appreciates cont.

Workforce development

- Local Contractors and community residents work in these demanding jobs
 - Be sure your workforce, including contractors, are front and center at any meeting with Members and their staff. Have them talk. On a site where work is ongoing is best, but any meeting is good.
 - It's a good idea to mention recent retention problems, (**in a positive way**): "given their skills, we have challenges keeping this workforce when homebuilding is booming. Pending legislation in both House and Senate may help by increasing the current cost limits."
- WAP supports training in both general retrofit skills and energy efficiency measures installation


The Visit: Points everyone appreciates cont.

Effective and transparent

- Show printout of parts of the SWS (Standard Work Specifications) manual
- Say "Every home is inspected by an independent qualified Inspector at the end of the job." Have an inspector present to tell what they inspect for and about their training.
- Say "The list of measures that can go into a home is limited by the audit/priority list tool; only those items that will reduce usage for many years plus some basic safety measures can be included." Have audit output and the job task list there to review with the visitors.

The Visit: Key Components

- Bring the Member to an **active worksite** where they can see demonstrations of work being done and **meet workers**.
- Invite **the family** whose house is being worked on so the Member can put a face to the program. If the family is not available, you can invite a family who has already had their home weatherized so they can discuss the real world impact.
- **Take photos!** When possible, take action photos as well! These are great for press releases and social media!
- Say **thank you!**



Check in with the lawmaker's office about inviting press!
