What the SOP?

Many operating principles in agencies and state offices rely on informal habits that are often described as “the way we have always done it.” This workshop explores how Standard Operating Procedures (SOPs) can strengthen performance management, especially for subgrantees who may be struggling. Participants will learn how SOPs help ensure consistent and reliable data that can be used to tell compelling stories about Community Action’s impact. Topics will include universal intake, customer life cycle tracking, the use of AI tools to streamline reporting and analysis, and strategies for connecting services and outcomes across multiple domains through bundled services, scales, and effective follow-up practices.

Rooted in Hope: Centering Community Voice to Strengthen Trust and Impact

Community Action has always drawn its strength from deep roots grounded in the lived experiences, resilience, and wisdom of the people we serve. In a moment marked by uncertainty and rapid change, staying rooted in hope requires us to listen more deeply, engage more intentionally, and elevate voices that too often go unheard.

Drawing from principles of local journalism and nonprofit engagement, this session invites us to reimagine what it means to truly center community voice. Through intentional listening and authentic storytelling, we will explore how narrative can deepen trust, strengthen engagement, and amplify the impact of our network. Participants will be challenged to think differently about how stories are told and how elevating lived experiences can shape public understanding, influence policy, and strengthen program

effectiveness – while honoring the dignity, resilience, and agency of those most impacted by poverty.
