From Strategy to Impact: Advancing Energy Efficiency Workforce Development in Oregon

The Oregon Energy Conservation and Weatherization Training Program, funded by the U.S. Department of Energy (DOE), was launched in 2024 to respond to workforce challenges experienced by WAP programs and contractors in Oregon. This session will discuss lessons learned while developing and implementing a statewide program that integrates U.S. Department of Labor, DOE, and industry needs, the transition of program funding from DOE to utilities, and strategies to maintain a human-centered, outcomes-driven approach to workforce development. Maximizing IIJA: Best Practices for State Plan Implementation

This session will introduce the IIJA Best Practices Guide, developed by the NASCSP IIJA Implementation Working Group to help Weatherization Assistance Program grantees successfully modify and implement their IIJA State Plans.
